- Approval of issue of Confirmation Allocation Note for the allocation of 99,46,785 Equity Shares of face value Rs.2/- each to the Qualified Institutional Buyers.
- Approving and adopting the Placement Document dated March 12, 2018 in connection with the QIP.

The meeting of the Committee commenced at 4.50 p.m and the meeting concluded at 5.20 p.m.
